TITLE: ACCOUNTING CLERK I

POSITION SUMMARY:

The primary purpose of this position is to process all information relating to the District's accounts payable and encumbrance systems in a timely and accurate manner.

MINIMUM QUALIFICATIONS:

- 1. High School Diploma or equivalent.
- 2. Criminal history clearance.
- 3. Demonstrated basic skills through a district skills assessment.

ESSENTIAL FUNCTIONS:

- 1. Manages and maintains the District's Accounts Payable and Encumbrance Systems.
- 2. Prepares accounts payable vouchers for payment and quality check purchase orders.
- 3. Reviews vendor statements for open items.
- 4. Processes expense reimbursements.
- 5. Responds to questions from vendors and other District personnel.
- 6. Processes and enters all accounts payable hand checks.
- 7. Prepares annual reports and filings.
- 8. Operates office equipment including calculators and computers for accounting tasks.
- 9. Understands, interprets, and follows instructions accurately.
- 10. Assists Accountant as needed.
- 11. Works harmoniously with others and communicates effectively (both orally and in writing) with students, parents, and staff.
- 12. Operates a computer and views a computer screen for prolonged periods of time.
- 13. Frequent and prolonged talking/hearing conversations.

OTHER REQUIREMENTS:
